Thoughts On Fairfield Glade

The Board is not meeting member expectations. The owners' response to the October 2024 survey that rated both the Board and management with a score of 29 out of 100. The average score of all associations was 61. This is not a small number of disgruntled owners but a real problem. Suggestions from the focus groups have been mostly ignored. Need less secrecy and more openness to rebuild trust. If Elected, I Will Strongly Advocate To:

1. Replace the Association's attorney.
2. Severely narrow or restrict use of nondisclosure agreements (NDA's).
3. Follow the TN Open meetings act. Regular Board business should NEVER be held in executive session.
4. Tree policy must be enforced and comply with Core Value #6.
5. Need a more constructive partnership with the Declarant, no more give aways!
6. Board must do a better job of educating the members on why difficult changes need to be made.
7. Must restore members' trust in the Board and its decisions
